JUST SAY YES

Last October, my nurse manager, Janet Habeshian, MSN, RN, asked me to be a member of the NICHE (Nurses Improving Care for Healthsystem Elders) Leadership Team and to assist in piloting NICHE on our unit, 7 Central. My first instinct was to say "no" because it would be more work for me and I was afraid I would let people down. However, in the five years I have worked at Lahey, I have never had the opportunity to meet my colleagues who are the people "behind the scenes" making things happen, or to get a glimpse of what a project like this really involves. So, I said "yes," and, although it has involved more work than I initially realized, it has been rewarding both personally and professionally.

From the beginning, our team "clicked." We brought with us a passion for the elderly and a commitment to helping Lahey become a NICHE site. We learned that NICHE is a multidisciplinary approach to elderly care and that our goal was to gradually change the culture of Lahey to think in terms of the specialized needs of the geriatric patient. Who would not want Lahey to be a part of this? I also learned from our nursing leadership team that this initiative paralleled our Magnet goals; as a reflection of our Magnet designation, we always strive to improve patient care.

After a few weeks in the honeymoon phase, I wondered what I had gotten myself into: this was a lot of work! Everyone on the team had to review 14 modules, which required hours of home study per week. This was supplemented with webinars the team attended, teleconferencing discussions and weekly team meetings. As the weeks went on and we plugged away at our assignments, we realized, through group discussions, that our team was well on its way to achieve its goals. We had to complete difficult assignments on time, but we were all enjoying the fruits of our labors, as well as each other's company. In early December, Susan Gordon, ACNP-BC, joined our team as the NICHE Program Leader. Susan had successfully implemented the NICHE program at her previous place of employment. She helped us refine our action plan and look toward the future with very specific goals. On January 7, 2010, after submission of our action plan, we received notification that Lahey Clinic had been awarded the designation as a NICHE site. This news was very exciting for the group, and it made me extremely proud to be a part of this initiative.

I have learned so many new skills, including SWOT (Strengths, Weaknesses, Opportunities and Threats) analyses, vision statements, actions plans, and even how to get funding for projects. I learned that the people "behind the scenes" in the Nursing Department are a wonderful group of experts who are working very hard to make it better for us at

Lahey's Team Approach to Stroke Care Achieves Gold

Every year in the U.S., there are more than 795,000 incidences of stroke. Of these, approximately 144,000 people will die, and two-thirds of the survivors will live with moderate to severe disability. In an effort to reduce those numbers, Lahey Clinic took action and became a certified Primary Stroke Service (PSS) in 2005.

In 2006, Lahey received its first recognition by the American Heart Association/American Stroke Association for meeting evidence-based quality performance measures. In 2007, 2008 and 2009, Lahey received the Gold Performance Achievement Award in recognition of the sustained compliance with these same evidence-based measures.

Contributing to this achievement, 6 West Hospital (6WH) provides neuroscience nursing expertise and works in partnership with the Neurology Department, the Stroke Team and the Lahey Clinic Stroke Program Coordinators. In collaboration with the Emergency Department, 6WH Progressive Care and a multidisciplinary team, we strive to provide evidence-based, patient-focused care that yields optimal patient outcomes.

Methods utilized to enhance this collaboration on 6WH include multidisciplinary daily patient rounds performed at the patient's bedside, including 6WH staff nurses and the Neurology team. Additionally, Stroke Program Champion, Becky Chase, RN, BSN, CNRN, and Clinical Educator, Joan Cavanaugh, RN, MHA, CNRN, represent 6WH on the Stroke Program's Quality Review Committee.

The commitment to the development of neuroscience nursing expertise in order to improve clinical outcomes for stroke and all neuroscience patients is evidenced by the combined efforts of 6WH and the Neurology Department in providing a biannual Neuroscience Nursing Certification (CNRN) Preparation Program. Since its inception in 2008, this program has provided education to more than 20 participants and has yielded a total of five CNRNs. It takes teamwork and expertise to achieve and sustain continued performance improvement.

Transitions on the Road to Medication Safety

After almost two years, the implementation of BCMA (bar code medication administration) using CareFusion (now called Pyxis Point of Care) is "live" on all inpatient nursing care units. The long and arduous process is a major accomplishment for Lahey Clinic, considering that provider orders are still handwritten and all medication documentation was previously on hand-copied medication administration records (MARs). Many nurses, as well as pharmacy, information technology and vendor specialists, worked collaboratively to make this happen.

A challenge of our current system has been the inability for all users to see the same information in one place at the same time. Although information about medication orders and administrations is recorded electronically, information is "static" and can only be viewed by a separate log-on to the CareFusion application. Once in the application, a number of reports can get you to the information, but no one report contains all the information in an easily viewable and sortable format.

Work is ongoing currently to build and test the new BCMA application called KBMA (knowledge-based medication administration), which will be part of our new Eclipsys EMR (electronic medical record) called "iChart." This application will use bar code scanning technology to verify the five rights of medication administration and document them. The advantage of the new system is that the orders will be viewed from an eMAR (electronic medication administration record) that will be populated by pharmacy-verified orders that have been electronically entered by the provider. Teams of nurses, commonly referred to as "SMEs" (subject matter experts), along with pharmacy, project team and vendor specialists, are working to build and test the new pharmacy application and KBMA module. The many lessons learned through our current BCMA process have enabled us to build our new system in a way that will ensure nurses can seamlessly verify and document medication administration, and will help to provide a smooth transition.

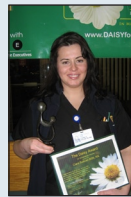

In the November/December 2009 issue of *Notes on Nursing*, I wrote about sustaining research excellence after Magnet designation and spoke about the new Magnet Model. According to *New Knowledge, Innovations, and Improvements*, the domain that speaks to research and evidence-based practice outcomes, organizations must describe the “structure and processes used to develop, expand, and/or advance nursing research” (American Nurses Credentialing Center, Magnet Recognition Program Application Manual, 2008, p. 50).

The Research Fellows Program, one of the key components of our Magnet exemplary nursing research initiatives, is one such process by which we *expand and advance* nursing research

In April, their role transitioned to testing the content that they have been validating.

Janet Habeshian was always able to put our hard work into words, so she became our spokesperson at all the teleconferencing sessions, always eloquently stating our priorities and goals, keeping them in line with the philosophies of Lahey as a true manager should. My conclusion is that, yes, things do get accomplished at meetings and, yes, people are working very hard behind the scenes to make things better for patients and nurses. My suggestion to nurses is to network, get involved and don't be afraid to participate. We have an abundance of resources available at Lahey and our input is valued.

The other thing I gained from this experience is that I don't feel like a little fish in a big pond anymore.
