BILH brings together academic medical centers and teaching hospitals, community and specialty hospitals, in a shared mission to expand access to great care and advance the science and practice of medicine through groundbreaking research and education.

LHMC serves more than 3,000 patients per day through our 335-inpatient hospital beds, our ambulatory care center, 24-hour emergency department and American College of Surgeons verified Level I trauma center. We are a teaching hospital for Tufts University School of Medicine with residency and fellowship programs for more than 130 new physicians in multiple subspecialties. As a research center, LHMC is involved in more than 200 clinical trial protocols.
